PROMOTING INNOVATION

VEGERATOR

As a representative college of RURAL AREA we aim at serving the rural people. SMALL SCALE FARMERS have been the immediate target of our efforts and eventually we came up with a cost effective cold-storing and refrigeration device that would to extend the benefit of these facilities to the marginal people who cannot afford to avail those. It was particularly designed to be a HIGHLY ECONOMICAL and PRIMITIVE FORM of mechanism, by means of which people can store perishable fruits and vegetables for a longer period of time without developing any bacteria, moulds or fungus on them. The device can be used both for domestic and commercial purposes. Small farmers, who do not have access to cold storage system, do harvest and sell their veggies in the market on daily basis. Not all their products are sold out in the market and those left out are wasted. Taking the help of the proposed technique they can store their veggies at least for 3-4 days after harvesting, WITHOUT COMPROMISING ANY NUTRITIONAL PROPERTIES in doing so. The basic tool can be modified according to the need. In 2022, the college has applied for TRADE MARKING the VEGERATOR DEVISED BY THE MEMBERS OF CANOPY. THE NATURE CLUB OF THE COLLEGE.




- [1] Detection of presence of aldultrant Metanil Yellow in turmeric powder.

LEICA MICROSCOPE

The microscope owned by the college is a rare asset of the institution which allows the viewers the advantage of viewing an object in its magnified form on a computer screen. In order to extend the benefit of the instrument to the local students, our college arranges demonstration of the device for the students of local schools and colleges.



RESEARCH CELL

To encourage the research activities among the faculty members of the college, the college authority allots some seed money to each department according to the financial budget of the year. An **Assessment Committee** maintains and monitors this seed allocation and utilization. The college also motivate the faculty members to write research projects and submit them to various supporting agencies like DST, AICTE, DBT, SERB, UPCST, DRDO, etc. In the last five years seven of our faculties have become involved in such research projects utilizing a total sanctioned amount of about twenty three lacs.

RESEARCH ON BUTTERFLY DIVERSITY AND ABUNDANCE IN LOCALITY

Butterfly diversity and abundance was studied in two different places of Hooghly district. One village and one urban area was taken up for the field study and their differences were noted. Pollard walk was followed for sampling in butterfly observation and counting. Total number of species found in Khanyan and Chinsurah Rice Research Station counted 40 and 29 respectively in 3 months post-monsoon period in a year. Among the species found in the Khanyan region 6 were very rare (VR), 14 were rare (R), 8 were not rare (NR), 11 were common (C) and 1 was very common (VC) species. On the other hand we found only 2 very rare (VR) species along with 11 rare (R), 7 not rare (NR) and 9 common (C) species in CRRS region. In Khanyan the highest abundant species was Catopsiliapyranthe (Mottled emigrant) and least abundant species was Castaliusrosimon (Common Pierrot) whereas in Chinsurah Rice Research Station Junoniaatlites (Grey Pansy) was highest abundant and Papiliopolytes (Common Mormon) was least abundant species. Both in Khanyan and Chinsurah family Nymphalidae showed highest abundance. Family Papilionidae was found least abundant in both places. The abundance of butterfly species can be correlated with the occurrence of their larval host plant and nectar plant in the given region.

Comparison of butterfly diversity of Khanyan and Chinsurah rice research station as a measure of habitat destruction

Abstract

Butterfly diversity and abundance was studied in two different places of Hooghly district. One village and one urban area was taken for the study and their differences were noted. Pollard walk was followed for sampling for butterfly observation and counting. Total number of species found in Khanyan and Chinsurah Rice Research Station was 40 and 29 respectively in 3 months post monsoon span in one year. Among the found species 6 were very rare (VR), 14 were rare (R) species, 8 were not rare (NR) species, 11 were common (C) species and 1 was very common (VC) species in Khanyan region. Whereas We found only 2 very rare (VR) species here alongwith 9 common (C), 11 rare (R) and 7 not rare (NR) species in CRRS region. In Khanyan the highest abundant species was Catopsilia pyranthe (Mottled emigrant) and least abundant species was Castalius rossimon (Common Pierrot) whereas in Chinsurah Rice Research Station himonia attites (Grey Pansy) was highest abundant and Papilio polytes (Common Mormon) was least abundant species. In Khanyan and in Chinsurah both places family Nymphalidae showed highest abundance. Family Papilionidae was least abundant found in both places. The abundance of butterfly species can be correlated with the presence of their larval host plant and nectar plant.




